***General wellbeing:** Buyer agrees to provide the dog/puppy a safe environment, exercise, nutritious food, and routine healthcare. Buyer agrees that under **no circumstances** is dog/puppy to be released to or sold to any establishment such as a pet store, shelter, pound, humane society, research facility, or used in violent activities such as dog fighting.

***Transfer of Ownership:** If at any time, Buyer can no longer retain possession of dog/puppy, Seller **must** be notified and the dog/puppy will be returned to Seller at Buyers expense. (We care very much for the puppies we raise and they are always welcome to return to us under **any circumstances**, no questions asked or explanations needed.)

***Release of Claims:** Seller is released from any and all expenses, liabilities, damages, or injuries caused by dog/puppy after placement with buyer.

***Payment:** Payment is due in full and must have cleared prior to release of dog/puppy to Buyer. We only accept cash on day of pick up if there is an outstanding balance.

***Registration:** We are proud of our puppies, so we ask that our kennel name **Triple-T-Terriers** be in your dog/puppy NRTR registered name. If show/breeding rights are desired please be advised that we cannot make any guarantees regarding the suitability of a puppy as a show or breeding prospect when fully grown.

***Dog/Puppy is guaranteed** to be in good health, to the best of our knowledge, at the time of this sale. Seller does not guarantee against any communicable diseases beyond 72 hours after buyer receives the dog/puppy.

***Dog/Puppy has been vaccinated** against Distemper, Parainfluenza, Parvovirus, Adenovirus Type 1 & 2, and Leptospirosis at _____ weeks of age. The puppy has also been de-wormed, per veterinarian's instructions. However recurring parasites (including but not limited to giardia, coccidia, roundworms, tapeworms, hookworms, pinworms, fleas, and ticks) are a

very common issue in young animals (especially in puppies) and are easily treated, and are therefore not covered by this warranty. The buyer will receive a copy of the vaccination/de-worming records performed on puppy.

The Buyer has a health guarantee extending to the 7th day after the purchase date in which to have the puppy examined by a licensed veterinarian for confirmation of the health of the puppy, and the buyer is urged to do so.

*This warranty does not cover: common/nonlife-threatening/trivial conditions, and those that cannot be tested for including but not limited to: undescended testicles, recessed vulva, urinary tract infections, entropion, ectropion, umbilical hernia, puppy strangles, over bite, under bite, temperament flaws, or poor disposition. In order for the warranty to be honored the following criteria need to be met.

1. A letter from the examining veterinarian shall be provided as evidence of the puppy's illness.
2. The seller shall be notified immediately of any issue before any treatment or procedures has been performed.
3. The puppy is returned within 48 hours of the veterinarian findings.



As the Seller, I certify that this dog/puppy has been examined by a licensed veterinarian, de-wormed, and vaccinated; and is free from illness and defects to the best of my knowledge. This agreement is valid only for the original Buyer named herein and is non-transferable.
