**Release of Claims:** Seller is released from any and all expenses, liabilities, damages, or injuries caused by dog/puppy after placement with buyer.

**Payment:** Payment is due in full (Checks must have cleared) prior to release of dog/puppy to Buyer. We only accept cash on day of pick up if there is an outstanding balance.

**Registration:** We are proud of our puppies, so for both that reason and the requirement of NRTR, it is important that our kennel name TripleT Terriers be in your dog/puppy's NRTR registered name. **If show/breeding rights are desired please be advised that we cannot make any guarantees regarding the suitability of a puppy as a show or breeding prospect when fully grown.**

**Puppy Health:** Dog/Puppy is guaranteed to be in good health, to the best of our knowledge, at the time of this sale. Seller does not guarantee against any communicable diseases beyond 72 hours after buyer receives the dog/puppy.

**Dog/Puppy:** has been vaccinated against **Distemper, Parainfluenza, Parvovirus, Adenovirus Type 1 & 2, and Leptospirosis** at \_\_\_\_\_ weeks of age. The puppy has also been dewormed, per veterinarian's instructions. However recurring parasites (including but not limited to giardia, coccidia, roundworms, tapeworms, hookworms, pinworms, fleas, and ticks) are a very common issue in young animals (especially in puppies) and are easily treated, and are therefore not covered by this warranty. The buyer will receive a copy of the vaccination/deworming records indicating procedures performed on and vaccinations received by puppy.



**Health Guarantee:** The Buyer has a health guarantee extending to the 7th day after the purchase date in which to have the puppy examined by a licensed veterinarian for confirmation of the health of the puppy, and the buyer is urged to do so.

**This warranty does not cover:** Warranty **DOES NOT** cover common/non-life-threatening/trivial conditions, and those that cannot be tested for including but not limited to: undescended testicles, recessed vulva, urinary tract infections, entropion, ectropion, umbilical hernia, puppy strangles, over bite, under bite, temperament flaws, or poor disposition.

**Reproductive Rights:** This puppy is being sold **without** reproductive/breeding rights unless the breeding rights section (above) is marked **YES** and the additional fee for breeding rights has been paid. **As such it is the buyer's responsibility to have the puppy spayed or neutered and to provide documentation to Triple T Terriers upon completion of the procedure** (generally age 5-8 months). **Buyer must further ensure that the animal does not breed/stud prior to the procedure.**

2. The seller shall be notified immediately of any issue before any treatment or procedure(s) has been performed and authorize any such treatment or procedure(s).
3. The puppy is returned within 48 hours of the veterinarian findings.
